CODIAC SOCCER – REFUND POLICY



House League Policy

Prior to the start of the season, refunds will be granted for the registration paid **minus a \$20.00 administration fee**.

A full refund will be given if a player cannot be placed on a team.

No refund will be given if:

- a player has received a uniform and has participated in at least one session
- a player has been dismissed for disciplinary reasons
- the request is made after July 10 of the playing season

Procedure for requesting House League refunds:

- All refund requests must be sent via email to CodiAC Soccer (codiacsoccer@nb.aibn.com)
- Refunds will be issued on May 31, July 5, and July 31.

First Touch Policy

Full Refunds will be granted in the following situations:

- First Touch is not able to field a team for the age division for which registration fees have been paid (refund of try-out, registration, and select fees paid).

Partial Refunds will be granted in the following situations:

- A player withdraws prior to tryouts (refund of registration and tryout fees paid **minus a \$20.00 administration fee**)
- A player withdraws after attending at least one tryout, but prior to team selections having been made (refund of registration fee **minus a \$20.00 administration fee**)
- A player makes the team for which he/she has tried out, but withdraws from the team prior to the first match (refund of registration and select fees paid **minus a \$50.00 administration fee**)
- A player makes the team for which he/she has tried out, but decides to play House League (refund of Select fee)
- A player fails to make the team for which he/she is trying out, and the player opts not to play House League (refund of registration fee)

No refund will be given if:

- A player makes the team for which he/she has tried out and has participated in at least game
- a player has been dismissed for disciplinary reasons
- the request is made after June 15 of the playing season

Procedure for requesting First Touch refunds:

- Refunds will be issued on May 31, July 5 and July 31.

Summer Camps and other programs

Refunds for all programs, other than House League and First Touch, are subject to a **minimum \$20 Administration Fee** unless otherwise specified at the time of registration.

Cases will be reviewed if:

- a player is injured, or has developed a medical condition
- a player has moved out of the Moncton area
